Auction Rules and Regulations for Dealers

BUYING VEHICLES

1. **In order to bid at the auction**, you must register by filling out and signing the entire registration packet, providing us with a copy of your dealer's license, business license, and ID's for owner and all salesmen authorized to purchase. (Owners/general managers must approve additional agents). The dealership/company will then be issued a permanent bidder number.
2. **We require that you pay for your purchase the day of the sale!** Payments may be made with cash, ATM (fee required), or by company check. **Notice: If you have not paid for your purchases by the following Thursday at 12:00pm, a 10% late fee will apply!**
3. **Remember that all vehicles are sold on an "as is/where is" basis** (no guarantees); however, any deficiencies of which the seller is aware will be mentioned by the auctioneer.
4. **A BUY FEE WILL BE ADDED TO THE PRICE OF EACH PURCHASE. PLEASE REFER TO THE FEE SCHEDULE FOR THE APPROPRIATE FEE TO BE APPLIED.**
5. **Upon payment of your entire purchase(s), you will receive a title** based upon its status that was announced by the auctioneer. This status will also be noted on the invoice you receive for that vehicle.
6. **We request that you remove the vehicles you have purchased from the auction premises on the date of the purchase.** We will not be held responsible for any losses or damages done to the vehicle after it has been purchased.
7. **FOR SAFETY AND INSURANCE REASONS, NO ONE UNDER 18 WILL BE ADMITTED.**
8. **ALL GUESTS MUST PAY \$5 PER PERSON;** however, no more than two guests per dealer are allowed!

PLEASE NOTE THAT THIS IS NOT AN ABSOLUTE AUCTION. SOME VEHICLES ARE SUBJECT TO PRICE CONFIRMATION BY THE SELLER/CHARITY REPRESENTATIVE.

SELLING VEHICLES

1. **When the vehicles are delivered, you must:**
 - a. Provide a completed and signed **Vehicle Consignment Form**. (See form below)
 - b. Provide the necessary paperwork to transfer the ownership of the vehicle. DMV paperwork is now available to you upon request. **PLEASE REMEMBER ONE OF OUR SELLING POINTS IS THAT WE SUPPLY THE TITLE IMMEDIATELY AFTER PAYMENT, SO PLEASE COMPLY WITH THIS REQUEST!**
2. **NUMBERS IN THE ORDER THAT YOUR VEHICLE WILL BE RUN IS ON A FIRST COME FIRST SERVED BASIS. YOU MAY DROP OFF YOUR VEHICLES ANY DAY DURING BUSINESS HOURS BEFORE WEDNESDAY TO ENSURE THAT YOU WILL RECEIVE A "GOOD" NUMBER.**
3. Upon the sale of your vehicle, you will be charged a selling fee, plus any other fees you may have authorized. Please refer to the fee schedule for the appropriate fees that apply.
